Ann Hull won the Grand Prize for her photo 'Just me and my Great-Grampa'. Category winners





Exploring Franklin County, VT the 21st Century Way

To celebrate the Lake Champlain Quadricentennial and National Trails Day 2009, MVRT Council members offered to take outdoor enthusiasts on guided recreational outings in Franklin County. A paddle, two bike rides and a hike were selected to highlight the natural history and scenic beauty of Northwestern Vermont.



On May 30, Rail Trail Council Chair Dave Stanley led a group of a dozen kayakers on a 4-hour paddle through the Missisquoi National Wildlife Refuge. Starting at Louie's Landing, the group followed the Missisquoi River to Missisquoi Bay, crossed about a mile of open water, and returned to Louie's Landing via Dead Creek. It was a gorgeous day except for the short period of time when some really interesting cloud formations turned into a very windy and wet storm – there

was some very fast paddling as people headed for the relative shelter of Dead Creek!

Our fourth outing was a hike up Burnt Mountain in Montgomery Center on August 15 led by Council members Jane Williams and Alisha Sawyer. It was a sunny but incredibly hot and humid day, and the intrepid hikers were rewarded with lunch and fabulous views of Jay Peak, the Trout River valley, and Quebec when they

reached the 2600' summit. The climb is about 2.4 miles each way with about 1,600' of ascent.

Bathrooms

Rail trail restroom facility gets city water

Public restrooms, the only ones of their kind, located along the Missisquoi Valley Rail Trail (MVRT) will be open beginning May 1, according to developer Phil Gerbode.

The seasonal facilities will be open to the public from May to September.

Completed in 2006, the pavilion is maintained by the homeowners association for the adjacent Village at Franklin Park. The delay in opening the restrooms was the result of what Gerbode characterized as a lengthy negotiation between St. Albans City and the association over the cost of providing water and sewer hookups to the facility.

The city had insisted that the association pay for a full residential hook-up, the smallest unit available, according to City Manager Dominic Cloud. The cost of a residential hook-up is \$5,000.

Because the pavilion is only open for five months out of the year and will use much less water than a home, the association asked for a pro-rated fee. The city has now agreed to a \$500 hook-up fee. "We really appreciate what Dominic Cloud has done to facilitate this." Gerbode said.

The Pavilion building is located within Franklin Park near the I-89 overpass less than a mile from the MVRT railhead in St. Albans City.

New Trail Surface

Plans to resurface the entire MVRT next summer are underway. VTrans will be putting the project out to bid this month and a contractor will be selected early in the new year. This work is being funded by federal stimulus dollars being spent here in Franklin County!

In preparation for the resurfacing, VTrans District 8 staff have been repairing or replacing old culverts and cutting back vegetation in the shoulders so that the resurfacing trucks will have sufficient maneuvering space to do their work.

Parking Areas

This project is still alive and progressing! In order to determine the extent of coal ash present at the planned East Berkshire parking area site, the State hired The Johnson Company of Montpelier to conduct an environmental assessment. We are presently awaiting the results of this assessment and whether further remedial action is required.
