New Parking Area at Green's Corner

It's finally happened, the MVRT now has a new and improved parking area on Route 105 very near trail mile 3, commonly known as Green's Corner! Those of you who have been following the progress of this project might recall that the Council was originally awarded grants in 1998 and 2001 to develop several parking areas and install amenities. and North Sheldon were completed, however many unforeseen details resulted in delays and insufficient funding to complete the Green's Corner parking area. In 2012 the Council voted to turn the project over to VTrans. Many thanks to the District 8 crew for making the parking area a reality last Fall! The relocated access greatly improves the line of sight so that exiting from the parking area is now much safer than it used to be.



Update Lamoille Valley Rail Trail

On August 27, a 17-mile section of the LVRT was officially opened! Stretching from St. Johnsbury to Joe's Pond in W. Danville, this section has a crushed stone surface and trail users pass through several huge culverts. The

views are stunning and the grade slightly downhill going from W. Danville to St. J.

The 17 mile stretch between Morrisville and Cambridge Junction is in its final stages of

construction and is due to open soon, perhaps this fall.

The section we're most excited about, 11 miles between Swanton and Sheldon Junction, is next on the agenda. Next summer the engineering work will be done and several FEMA sites in the Highgate area will be repaired. Construction of the trail is expected to take place in summer 2017 The LVRT will intersect with the MVRT in Sheldon Junction behind Bourdeau Brothers.

A capital campaign will be underway soon to raise the funds necessary to construct the remaining sections of the LVRT eventually creating a seamless 93-mile long recreational path in Vermont stretching from St. Johnsbury to Swanton.
